Dear Mr. Ravnitzky:

This is in final response to the request for information you sent to the Department of Energy (DOE), Office of Scientific and Technical Information (OSTI) under the Freedom of Information Act (FOIA), 5 U.S.C. 552 on June 22, 2016.

You requested a "copy of records, electronic, or otherwise, of each letter TO and FROM universities, companies, and organizations, from the OSTI 'cold fusion' documents collection." On July 11, 2016, you were emailed an interim response letter informing you of the need for OSTI to obtain release authorization from the Department of Energy. OSTI received notification to release the letters to you in their entirety on August 8, 2016. As a result, OSTI is releasing 72 cold fusion letters in this mailing on a CD-ROM because of the volume and file size of the PDFs.

In addition, there are approximately 13 letters that are currently being reviewed by the DOE's General Counsel Office (GC) for release or redaction. Upon receipt of guidance from GC, OSTI will release in whole or in part.

This decision, as well as the adequacy of the search, may be appealed within 90 calendar days from your receipt of this letter pursuant to 10 C.F.R. § 1004.8. Appeals should be addressed to Director, Office of Hearings and Appeals, HG-1, L'Enfant Plaza, U.S. Department of Energy, 1000 Independence Avenue, S.W., Washington, D.C. 20585-1615. The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal to OHA.filings@hq.doe.gov, including the phrase "Freedom of Information Appeal" in the subject line. The appeal must contain all of the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either: 1) in the district where you reside; 2) where you have your principal place of business; 3) where DOE's records are situated; or 4) in the District of Columbia.

This firm represents William L. Telander. In 1992, Mr. Telander assisted in setting up a scientific research group which included Mr. Joe E. Champion, Jr., and Dr. John O'M. Bockris, Distinguished Professor of Texas A & M University. The name given this group by Mr. Telander was The Philadelphia Project.

This letter is to put you on notice that on May 14, 1992 Joe E. Champion, Jr. assigned, transferred and conveyed to William L. Telander any and all interest he then had and/or may acquire in certain scientific theories, technologies, and/or related experimentation or findings that may be discovered or result as more fully set forth in a copy of said assignment attached hereto and made a part hereof.

Mr. Telander has reason to believe that Mr. Champion or certain persons on his behalf are presently promoting the scientific theories as recited in the above assignment as Champion's or their sole intellectual property rights and that Mr. Champion or such persons are therefore violating the specific terms of said assignment. Mr. Telander has further reason to believe that certain persons have come into possession of said scientific theories and formulae as recited in said assignment and are promoting such theories and/or formulae as their own intellectual property rights.

Mr. Telander therefore considers and gives notice that any participation in the promotion of said scientific theories and/or

formulae shall be viewed as a tortious interference with the property rights enumerated in such assignment. Mr. Telander further gives notice that he has been named as a defendant in an action entitled SEC v. Southwest International Exchange, et al., Case No. 93-1285, pending in the United States District Court, Central District of California and an "Order of Preliminary Injunction and Orders: 1) Freezing Assets; and 2) Prohibiting Transfer of Assets and Destruction of Documents" was entered in that case on March 25, 1993. Mr. Telander considers the aforementioned assignment as an asset frozen under the above order.
